

LEWISVILLE PUBLIC ART ADVISORY COMMITTEE MEETING MINUTES

August 4, 2025

Lewisville Town Hall

- I. **Call to Order** – Chair John Armbruster called the meeting to order at 6:00 PM. In attendance were John Armbruster, Barbara Campbell, Deirdre Mullen, Daniel Robinson, Rebecca Scherbak, and Town Clerk Angie Lord. Absent from the meeting were Elizabeth Miller and Sarah Reece.
- II. **Agenda Approval** – Deirdre Mullen moved to approve the agenda. Barbara Campbell seconded the motion and motion passed unanimously.
- III. **Minutes Approval** – Deirdre Mullen moved to approve the July 7, 2025 minutes. Daniel Robinson seconded the motion and motion passed unanimously.

IV. Old Business

A. Shallow Ford progress

- Public Art Vision (Celebrate Our Culture through Art – Arts Alive) Town Clerk, Angie Lord provided images submitted by Elizabeth Miller, Deirdre Mullen, and Rebecca Scherbak. Discussion ensued regarding use of the icon; Council review and approval; and a banner for the unveiling event. The committee held discussion on selections; and requested revisions with a consensus to move forward with submission #1 with a deeper grade, larger/thicker fonts, and to change the zip code to reflect NC. Town Clerk Lord advised once the revised icon was received, an agenda item would be placed on a Council agenda for consideration.



- B. **Permanent Art Selections (MAWCC/GWR)** – Chairman John Armbruster outlined the need to review selections for ranking; voiced concerns of fund reallocations in the new year; referenced a potential to table the items; and spoke to future collection additions. Discussion took place regarding artist restrictions; the need for larger pieces, a possible All Call for artwork to reflect the spirit of the community; art etiquette; selection of at least one piece; and sending an email to request digital pictures. It was the consensus of the committee to send an email to 5 artists selected by the committee requesting submissions for the Great Wagon Room, keeping with the spirit of the community with a submittal deadline of October 31st. Barbara Campbell will compose an email to be sent to the selected artists: Becky Tyson, Amy Cruz, Rita Long, Marianne Hale, and Linda Grace.

V. New Business

- A. 2026 Community Day representative nomination – Barbara Campbell moved to nominate Deirdre Mullen or Sarah Reece. Daniel Robinson seconded the motion to nominate Deirdre Mullen and motion passed unanimously. Ms. Mullen explained that she would seek assistance from Elizabeth Miller.

- B. Need Called meeting – September 2, 2025 – Barbara Campbell moved to have a called meeting on September 2, 2025 for the purpose of planning the Shallow Ford unveiling event. Rebecca Scherbak seconded the motion and the motion passed unanimously.
- C. Need Called Meeting – September 29 or October 7 – John Armbruster moved to hold a called meeting on October 7, 2025 for the purpose of planning an art call for the 2026 Art Show. Deirdre Mullen seconded the motion and motion passed unanimously.

- A. MAWCC Mural Plaque update – Town Clerk Lord provided an image of the plaque placed under the “Beginnings” mural at the Mary Alice Warren Community Center.
- B. Shallowford Square – Shallow Ford Installation/Unveiling
 - Shallow Ford signage / plaque – Town Clerk Lord shared that staff were working on getting a quote for the Shallow Ford plaque which would be an estimated \$370 plus taxes and installation.
