Special Called Meeting September 2, 2056 Lewisville Town Hall

- I. Call to Order Chair John Armbruster called the meeting to order at 6:00 PM. In attendance were John Armbruster, Barbara Campbell, Elizabeth Miller, Deirdre Mullen, Daniel Robinson, Rebecca Scherbak, and Town Clerk Angie Lord. Sarah Reece was absent from the meeting. Special guest Paul Spainhour was in attendance.
- II. **Agenda Approval** Elizabeth Miller moved to approve the agenda. Barbara Campbell seconded the motion and motion passed unanimously.
- III. **Minutes Approval** Daniel Robinson moved to approve the August 4, 2025 minutes. Deirdre Mullen seconded the motion and motion passed unanimously.

- A. Shallowford Square The Shallow Ford Sculpture Unveiling and Reception
 - <u>Finishing Samples</u> Artist Paul Spainhour explained the hot rolled Patina finish on the samples provided; and the assistance of Big D's Mobile Blasting. It was the consensus to approve the finishing on the sculpture as presented by Mr. Spainhour.
 - <u>Shallow Ford signage update</u> Town Clerk Angie Lord outlined the options and quotes for an in-house banner provided by staff or a banner provided by Signarama. In-house cost would be approximately \$50 with an outsourced banner costing \$179 (one sided) or \$247 (double sided). John Armbruster moved to approve a Plan A order with the Arts Alive icon, and a Plan B with the Town logo should Council not approve the icon. The motion was seconded by Deirdre Mullen and passed unanimously.
 - Town Clerk Lord outlined the cost of the medal cast plaque at \$1,194.85; and explained the piece could be ordered soon for placement before the reveal.
 - <u>Unveiling and Invite</u>- Town Clerk Lord shared staff would meet with Mr. Spainhour next week
 to plan for the installation; and stated Town Council and the Shallowford Foundation would
 be invited to the unveiling. Discussion took place regarding invitations to former committee
 members, former Shallowford Foundation employees, and the master art distribution list.
 - Reception Discussion ensued regarding committee name tags, flowers for the table, balloons, water and lemonade for beverages, cookies and brownie/lemon squares for refreshments. Committee members will arrive by 5:15 PM for set up. Discussion continued regarding advertisement of the event at the Mary Alice Warren Community Center and the Public Library; staff providing a podium/stand; Daniel Robinson supplying a amplifier/mic; and staff inquiring about a mug to give to the artists. Barbara Campbell stated she would be out of the country for the event.
